- 1) INTERPRETATION: In the rules and regulation unless there is anything repugnant or inconsistent there with:
- (A) Society / Committee :- Designo Group of Education Society, Nagpur.
- (B) 'President' Shall mean head of the Designo Group of Education Society, Nagpur.
- (C) 'Vice President' shall mean the vice president of the Designo Group of Education Society, Nagpur.
- (D) 'Secretary' shall mean the secretary of the Designo Group of Education Society, Nagpur.
- (E) 'Joint Secretary' shall mean the secretary of the Designo Group of Education Society, Nagpur.
- (F) 'Treasurer' shall mean the secretary of the Designo Group of Education Society, Nagpur.
- (G) 'Member' shall mean the secretary of the Designo Group of Education Society, Nagpur.

2) AREA OF OPERATION :-


The area of the operation of the society shall be in India.

3) ACCOUNTING YEAR :-

The accounting year shall start from 1st April to 31st march every year. The accounts shall be balanced each year on the 31st March.

4) MEMBERSHIP AND ITS ENROLMENT :-

- (A) Governing body through its president/secretary in writing may from time to time call upon the members of committee as.
- (B) The member shall be intimate his consent in writing to the Governing B Body through its present and should sign the register of the member maintain by the committee in token of such consent.
- (C) The governing body has such a power and the writes to accept or reject any application from membership without assigning any reason.

(D) Any person who is competent to enter into the contract and who is interest to serve the cause of society and who is desire to contribute to the best of his ability for the growth of the society can become the member of the society. However the executive committee may decline the membership to any applicant without assigning the letter.

5) Types of Membership :-

Anybody devoted to work in the field of education, and willingly to follow the rules and regulations and purse the time of the society can become a member as follows:

- (A) Founder member: Persons who are the persons who are paying Rs. 500/at the time of registration under the Society Registration Act-1860 shall be the founder member. Members of the founder members are not exceeding above seven in future. If in future any vacancy arises as a result of the resignation or the death of any founder member the managing committee will fill the same.
- (B) Patron member: Prominent persons from various fields may be made patroness who may give valuable guidance to society. The executive committee may invite particular. Those persons will pay an amount of Rs. 750/-
- (C) <u>Life member</u>: Those persons who pay Rs. 1000/- will be made life members. Any individual who has completed a age of 18 years can becomes a life member by paying the prevailing fees.
- (D) Ordinary Member: Those persons who pay Rs. 250/- will be made ordinary members. Ordinary members have to pay the membership ship fee yearly.

6) Disqualification of Member :-

- [1] A member shall be disqualified to be a member on the following ground and reasons.
- (a) On his / her death
- (b) On his / her resignation from the member ship of the society
- (c) He / she becomes of unsound mind
- (d) He / she is of hindrance to the aim of the society
- (e) He / she who is declared insolvent.
- (f) He / she does not subscribe his membership fees and remains in arrears for a maximum period of the 3 months.

8) Notice of General Body Meeting :-

It shall be obligatory to give notice of general body meeting to the member at least 15 days before the date of meeting. The notice shall give all the details of the date, time, place, and agenda of the meeting. The notice to the member sent on the Dak-book and receiving member should sign the receipt. Any notice send by Regd. Post shall be dispatched 20 days prior to the date of general body meeting. Quorum of the general body meeting shall consist of presence of at least 2/3 members. The meeting shall stand adjourned for 30 min. for want of quorum and for such adjourned meeting no

9) Special General Body Meeting :-

May be converted to attend to some special necessity or undertaking some very important work.
